<p>1. Description of goods and / or services</p>	<p>No physical goods are sold through the Municipal website. The website / system processes electronic applications submitted from residents, contractors and others for Municipal type licenses, permits and memberships. Other services delivered through the system may include application and payment for special event registration such as a trip to a Broadway Play or recreational type use like little league registration.</p>
<p>2. Customer Service Contact Information</p>	<p>Customer Service Contact Information is posted on the website available to all system users.</p>
<p>3. Return Policy *</p>	<p>There are no physical items to return. However, refunds are available as described below in the refund policy and processed in accordance with Township Ordinances, State Law and / or special offer terms.</p>
<p>4. Refund Policy *</p>	<p>Refunds for Construction Permits are provided in accordance with New Jersey State law and Regulations specifically NJAC 5:23-2.27 and as adopted in the Township Ordinance and Construction permit fee schedule. <i>“In the case of discontinuance of a building project, the volume of the work actually completed shall be computed. Any excess for the uncompleted work shall be returned to the permit holder; except that all penalties that may have been imposed on the permit holder under the requirements of the regulations shall first be collected. Plan review fees are not refundable.”</i> The above italicized information is posted and available on the Township and State website(s). Refund information for special offer memberships such as the Swim Club or other event registration vary and are also provided in specific detail and posted on the Township Website which the User must read and physically accept and acknowledge by selecting a button prior to proceeding to check out and submitting a payment.</p>
<p>5. Cancellation Policy *</p>	<p>Cancellations are processed the same as refunds described above under State law and in accordance with Township ordinances and Municipal procedures.</p>
<p>6. Delivery / Shipping Policy *</p>	<p>No goods are physically delivered and or shipped. Selective Township services available on the website are open to resident and non-resident usage for Use within the constraints of the Township boundaries.</p>
